

**RELEASE AND WAIVER OF LIABILITY, AND ASSUMPTION OF RISK AND IDEMNITY,
AND PARENTAL CONSENT AGREEMENT: READ BEFORE SIGNING**

In consideration of being allowed to participate in any way in hunting activities and it's related events under the guidance of B&C Gamebirds, LLC, from _____20____ to _____20_____

I, _____, the undersigned, for myself, my personal representatives, assigns, heirs, and next of kin, acknowledge, appreciate and agree that:

1. I understand the nature of hunting activities and that I am qualified, in good health and in proper physical condition to participate in such activity. I further acknowledge that the hunting activities will be conducted over and on rough ground and timber and upon which hazards are associated with hunting are to be expected. I further acknowledge that the hunt will also be conducted on private property owned by individuals or entities which have agreed to allow hunting on their private property and upon which hazards of hunting are to be expected. I further acknowledge that the consumption of alcohol beverages during or prior to the hunting activities increases the danger from hunting and increases the risk of injury. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the hunt.
2. The risk of injury from hunting activities and it's related events is significant, including the potential for PERMANENT PARALYSIS, PERMANENT DISABILITY, OR DEATH, and while particular skills, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist. These risks and dangers may be caused by my actions or inactions, the actions or inactions of others of others participating in the hunt, the conditions in which the hunt takes place, or the NEGLIGENCE of the "RELEASEES" named below. There may be OTHER RISKS AND SOCIAL AND ECONOMICAL LOSSES either not known to me or not readily foreseeable at this time.
3. I KNOWINGLY, FREELY AND FULLY ACCEPT ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ALL RESPONSIBILITIES FOR LOSSES, COSTS, AND DAMAGES I INCUR AS A RESULT OF MY PARTICIPATION IN THE HUNTING ACTIVITIES.
4. I willingly agree to comply with the customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of B&C Gamebirds, LLC immediately.
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, IDEMNIFY, AND HOLD HARMLESS B&C GAMEBIRDS LLC, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and Cory W. Bennett, Robert W. Bennett, Beverly A. Bennett, Double B Turkey Farm Inc., Bennett Turkey Farms Inc., Leora R. Bennett, and all owners, lessors and lessees of premises used for or related to the hunting activities ("Releasees "), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with or related to my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE,

FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLGED TO BE CAUSED to the fullest extent by law.

I agree to take full responsibility for myself and my actions, following all the Nebraska Game and Parks laws and regulations. I am aware that safety is a high priority objective and I will use it as my primary guide for the actions that I take part in. My signature below constitutes acceptance of the above terms and conditions. I have read and fully understand this LIABILITY RELEASE.

I also confirm that at this time I have made full payment to Cory Bennett and B&C GAMEBIRDS LLC. If I haven't paid in full and leave the property, I agree to pay twice the balance due in full to Cory Bennett within 30 days.

MEDICAL RELEASE: Hunting

I further agree to allow and be financially responsible for any necessary emergency treatment by any available physician at any available medical institution in the event of my injury or illness.
